6. REPORTS

6.1 President – Martin Walsh

- 6.1.1 Boat Show went fantastic, despite few positioning problems on Thursday. Thanks to Glenn and all who rallied around and put in the effort.
- 6.1.2 Meeting (3.5 hours) 31 May: MSQ State Manager and SEQ Regional Manager, GC Water Police, AVCG (Ian Radcliffe, Ken Stanley), SWT Manager, Tony Jamieson, GC Waterways Authority's Hal Morris and host of others and VMR Keith Williams and Martin Walsh.
 - a. MSQ and GCWP have absolutely no problem with SWT operations.
 - b. GCWA has vision of 3 entities with them merely being the landlord with no decision making in daily role.
 - c. AVCG does not wish to participate under draft document and not returning until finalization of agreement
 - d. VMR is operating under draft agreement, so far to satisfaction of all
 - e. If SWT "fell over" VTS would take over the Maritime Safety Listening Watch.
 - f. LTO to be re-presented on 8 June

- g. Dept of Transport will be calling for tenders for repairs to SWT.
- h. Point of interest: Recent Broadwater speeds survey had 850 responders, the SWT survey had over 1000, 53% who were VMR/AVCG members, who want SWT to stay
- i. President is on all three forums involving The Spit and all simply acknowledge that the SWT is there with no major concerns for a different future
- j. No news is good news, so let's just keep doing what we are doing so well.
- 6.1.3 President demonstrated VMR Southport website for accessing RO (password 'radio') and Forum (password 'forum') Minutes and Membership application, renewal and information updating. Will be automatic annual renewal after email advice of anniversary. Incumbent on member to advise of cancellation of membership rather than VMR calling them. There is a free one year membership "STUDENT" membership with a \$15 administration fee for boating course graduates.

SWT called and speaking with 4 men in sinking vessel. Lots of radio and phone calls with offers to assist from commercial and private vessels hearing the Mayday call. Disappointed that no advice from GCWP that were safely retrieved, the media advised SWT RO. Keep logging and rewrite a MAYDAY log sheet with relevant entries after the matter has been finalized.

- 6.6.1 Sanctuary Cove Boat Show: Very successful outcome, on par with previous years despite the change of position on lack of boat space. Weather held up and effort put in by all because of the drama really appreciated.
- Have done boat show for 20 years, and despite saying it previously this is my last year in charge. Time for change. Funds raised have been similar over the past few years, so maybe new head with new ideas has potential for different results.
- 6.6.3 Busy days with medivacs: Skipper fell off mast when pivot point on his harness gave way, but held 3' from deck but he had hit his face on way down and landed on this legs, so in a pretty bad way.
 - 6.6.4 Vessel moored on SNOO is result of owner being told to remove vessel, so did it at night with a 6hp motor on side of his 39' ferro concrete vessel, crossing the seaway on outgoing tide and ending 2 km offshore when dropped his anchor when it was suggested to him and it fell off! GCWP happy with VMR response.

- 6.6.5 Whenever there is a situation reported by the media, only GCWP get credit for the action despite often not their action to finalise the matter. This matter being raised with GCWP hierarchy.
- 6.6.6 MR3 Replacement Committee have really put in an effort and visited numerous builders and suppliers, talked to other Bases and boat users and will be giving final recommendation to Management Committee at next meeting. Likely to be inflatable, number of motors being researched.
- 6.6.7 VMR Southport had two functions, radio and boats. Now have three with the SWT operation. We are smashing it we know what to do and we are doing it.
